# REPORT TO THE 2016 ANNUAL MEETING OF THE ABORIGINAL EDUCATION COMMITTEE

#### Committee Activities 2015-2016

The Aboriginal Education Committee met twice this year and held its third meeting via conference call.

The first meeting was held at the provincial office on Monday, November 20, 2015. Joan Hill-Keast was elected Chairperson for 2015-2016.

Committee members shared their personal and professional interests and histories.

Vice-President Karen Campbell provided ongoing support and guidance in the committee's work.

R. Mishenene, Executive Assistant with ETFO in First Nations, Métis and Inuit (FNMI) education portfolio, provided regular updates on ETFO FNMI initiatives to the committee members: Aboriginal Women in Leadership Programs Report; Two FNMI Online Book Clubs; Deconstructing Stereotypes Workshop for Locals; Engaging Aboriginal Families and Communities Workshop for Locals (WP); Engaging the Aboriginal Learner

Resource; FNMI Growth Chart; Webinars on Truth and Reconciliation; Brochure on FNMI Peoples and History; Aboriginal Education Symposium for ETFO Members; FNMI Member Sharing Circle; FNMI Member Workshop Development; FNMI Women Leadership Symposium; and FNMI Women Leaders Poster. The committee also shared additional information on Aboriginal education resources and events.

The committee reviewed the report of the Aboriginal Education Committee to the 2015 Annual Meeting. K. Campbell shared information on the motion that was passed at the 2015 Annual Meeting where ETFO endorsed the Calls to Action in the Truth and Reconciliation Commission Report, and that ETFO develop a webinar for members on the recommendations regarding education. The committee also reviewed the low percentage of Aboriginal members that participated in ETFO professional learning opportunities. In response to these, the committee made a recommendation to the Executive: "That ETFO include, wherever possible, Aboriginal content in future resources and professional learning opportunities, such as workshops and programs." Additionally, R. Mishenene developed and delivered two webinars on Truth and Reconciliation for members. The webinars are posted publically for all members.

The second meeting was held at the provincial office on Monday, February 22, 2016. R. Mishenene provided an update on the committee's recommendation regarding Aboriginal content in ETFO resources and professional learning. The motion was referred to the General Secretary for study and report to the June 2016 Executive Meeting.

The committee discussed the term "Aboriginal" as it relates to self-identification and the name of ETFO's standing committee. Two recommendations were made to the Executive: "That ETFO consider replacing the term Aboriginal in the self-identification of the application and registration forms section with the following three separate designated groups: First Nation, Métis and Inuit."; "That ETFO consider replacing Aboriginal Education Committee name with First Nation, Métis and Inuit Education Committee." The two motions were approved at the May Executive meeting.

R. Mishenene shared issues that were brought forward regarding the ETFO FNMI statement that potentially excluded other Indigenous groups that historically have shared or had a connection to the land in various areas throughout Ontario. The committee discussed having a more inclusive statement that acknowledges the diversity of Aboriginal peoples who inhabit or have inhabited a certain area. The committee put forth a recommendation that the statement be amended to read, "The Elementary Teachers' Federation of Ontario acknowledges and thanks the First Peoples of this territory and other Indigenous peoples for sharing this land in order for us to continue our work today."

The final meeting for the year was held Monday, April 18, 2016 by teleconference. The committee was provided an update on the recommendations.

#### **Committee Activities 2015-2016**

The committee met on December 3, 2015 and February 18, 2016. Greetings were brought by Vice-President Karen Campbell. During the first meeting, the committee appointed Samantha Hendricks as chairperson. The committee discussed the development of a short film illustrating the lived experiences of racialized teachers and develop tools and strategies to support ETFO members to combat racial prejudice and stereotypes.

At the February 18, 2016 meeting the committee was provided with a copy of the 2013 ETFO Racialized Members Focus Group Report. The rationale for the focus group was provided to the committee and time was given to review the report in its entirety. Committee members made personal connections to the examples provided in the report and discussed the final recommendations from the report. The group reiterated the need for a racialized members' space to network and support one another as these opportunities do not occur in their teaching day.

Chair S. Hendricks mentioned that there were vacancies on the Provincial Standing Committees. D. Cheng informed the committee that she has completed her 4-year term and will not be returning to the committee next year. Chairperson S. Hendricks thanked

D. Cheng for her commitment to the Anti-Racist Committee and looked forward to working with her again.

The committee was provided with copies of *ETFO's Canada's Diverse Athletes Poster* and a lively discussion was had about the early athletes portrayed, their accomplishments and their omission from the curriculum.

Members reviewed and discussed the agenda and format for the *Challenging Oppression Conference for Racialized Members*, and considered the necessity for a two-day conference. Committee members felt that a Friday (evening) and full day Saturday was not enough time to build networks and alliances and have courageous conversations around combating racism, prejudice and stereotypes.

The committee had a very successful year and moved forward several important issues including:

- The committee debated at length the positives and negatives of drafting a similar resolution as in previous year related to an increased number of designated seats on the Provincial Executive. The discussion included consideration of the information provided by Vice-President K. Brown Campbell and other committee members. The committee resolved not to submit a resolution to the 2016 Annual Meeting.
- Strategies and tools for supporting members to combat and respond to racial stereotypes and prejudice.
- Member feedback related to ETFO workshops provided to locals across the province to support teachers and schools in the arrival of Syrian refugees.

#### **Committee Activities 2015-2016**

The committee met twice during the 2015-2016 school year. The first meeting was held on January 14, 2016 and the second on April 28, 2016.

At the January 14, 2015 meeting, Martin Kay was acclaimed chairperson. After reviewing the Committee Guidelines, the committee reviewed the ETFO Arts position statements. Arts events for 2015-2016 were reviewed including ETFO's sponsorship of the *World Festival of Children's Theatre*. This event will feature troupes of children aged 7-16 years of age from 6 continents and the provision of professional learning workshops based on ETFO's popular Arts resources; *Primary ETFO Arts*, *Revised ETFO Arts* and *More than a Play* at the international PLAY Symposium from June 10-12, 2016. An update was provided on ETFO programs related to First Nations, Métis and Inuit (FNMI) activities and the Arts, including *Spirit Horse*, as well as ETFO Arts Book Clubs. A resolution to go forward to the Annual Meeting 2016 was proposed.

At the second meeting, a review of ETFO Additional Qualification course offerings, specifically in the Arts, was provided. The program for the PLAY Symposium was reviewed. In addition to updates, the focus of this meeting was to identify ways to bring

more Arts programing into the classroom and increase live Arts presentations in schools.

Topics discussed included: how to engage students in local theatre in the classroom; how to access local artists and bring Arts into the classroom; preparing students for the Arts experience and content extending into the curriculum; Arts and FNMI, and finding the Arts in mathematics instruction. Committee members discussed the fact that there are additional Arts resources in dance, drama, music and visual arts available from various subject association websites. A discussion was also held about how to increase awareness of the ETFO resources available so that these resources can get into the hands of ETFO members. It was suggested that ETFO explore e-copies, demonstration copies and order forms for the Arts publications.

#### **Resolution to the 2016 Annual Meeting:**

That Article XI, Local Organization, Section 2, Governance, be amended by the addition of a new section to read;

1.0 Each local shall endeavor to have an Arts Committee.

#### **Committee Activities 2015-2016**

The committee met two times during the year, on December 7, 2015 and February 8, 2016. The committee's activities in 2015-2016 included the following:

- At the first meeting, Aviva Rosenberg from the Peel Teacher Local was elected as the chairperson of the committee.
- The committee discussed the six recommendations they put forth to the Executive from 2014-2015. Members were briefed on the disposition of the recommendations.

#### **Committee Activities 2015-2016**

The Early Years Committee met on two occasions - December 11, 2015 and February 19, 2016. The committee's activities during 2015-2016 included the following:

During the first meeting, committee members:

- Discussed the ETFO Central Teacher and Occasional Teacher Agreement and the workgroups that were established as a part of the agreement.
- Identified continued issues in FDK: class size, and issues related to physical classroom size; planning time as a team and also for DECE members, violence in the early years, and mental health for staff and students.
- ETFO staff shared the final version of the *Kindergarten A Unique Program, A Unique Partnership* Pamphlet, which highlights the full-day kindergarten program and the unique, and common qualities of our DECE and teacher members.
- Discussed the Ministry's *Kindergarten Program* and *Kindergarten Addendum to Growing Success* and shared suggestions, issues and questions in regards to the implementation of these documents and how to best support our members with the implementation.
- Discussed unique challenges with professional learning for Kindergarten teams.
   Issues such as devoted learning time for teams and the different unions who represent DECEs and their professional learning offerings were discussed.

During the second meeting, the committee:

- Met with ETFO Executive Staff, Nancy Baldree to discuss mental health and wellbeing for children and staff. Various resources and supports were shared.
- Discussed the committee's ideas in regards to the need for collaboration time for Kindergarten teachers and DECEs. The committee discussed annual meeting resolution wording, rationale and crafted the resolution.
- Discussed efforts and supports being put in place for Syrian refugees.
- ETFO staff shared information about a webinar presented to local leaders called "Supporting Positive Team Relationships".

#### **Committee Activities 2015-2016**

The Education Support Personnel/Professional Support Personnel/Designated Early Childhood Educator Committee met on December 11, 2015 and February 12, 2016. The committee discussed and analyzed issues pertaining to Education Support Personnel (ESP), Professional Support Personnel (PSP) and Designated Early Childhood Educator (DECE) members. The committee's discussions in 2015-2016 included the following:

#### During the first meeting, the committee:

- Reviewed the committee's Terms of Reference;
- Discussed concerns related to the mental burnout and physical toll on members
  who are assigned to work with students who demonstrate aggression, explosive
  behaviours, and violence, as well as concerns that under-identification of such
  students and insufficient support for workers in this situation are prevalent in
  school systems; and

 Explored board practices when dealing with under-reporting of violent incidents and near-misses as they relate to kindergarten students and special needs students.

In addition, the committee liaised with the ETFO Standing Committee for Health and Safety where topics for discussion were:

- the need for effective reporting and deterrents to reporting incidents of violence and near-misses;
- eliminating barriers to reporting;
- the value of joint training with other bargaining units in a school board;
- the importance of a pro-active culture within a school board with regard to worker safety;
- issues related to WSIB, workplace illness and burnout; and
- the Action Zone of working with Kindergarten to Grade 3 students where members experience high proximity/high engagement working relationships with children.

During the second meeting, the committee:

- reviewed the processes related to the ETFO Benefits Trust;
- discussed the limitations of the funding formula structure which provides support for special needs, particularly as it relates to under-identified students or those with emergent issues;
- explored the challenges of identifying valid comparator groups to use as comparisons for the next round of collective bargaining, specifically in the area of compensation; and
- reviewed and discussed motions having direct impact on ETFO ESP, PSP and DECE members which have been submitted to the 2016 ETFO Annual Meeting.

#### **Recommendations to the 2016 Annual Meeting:**

- 1. That ETFO, through OTF, lobby the Ministry of Education and the Ministry of Labour for the installation of visual alarms in all classrooms and common areas of school board properties for fire and emergency situations.
- 2. That ETFO develop and offer a course at the Federation's expense that focuses on assisting members assigned in FDK classrooms. This program will be focused on inquiry based program support, partnership support and classroom management support.

#### **Committee Activities 2015-2016**

The committee held two face-to-face meetings. On November 19, 2015, the committee reviewed the outcome of resolutions they had submitted to the 2015 Annual Meeting. They discussed the challenges faced by FSL teachers obtaining enough resources to address the new curriculum. They discussed the lack of work space for rotary FSL teachers. There was a lengthy discussion about members having FSL part 1 being forced by some boards to teach core or immersion French when there was a staffing surplus situation. Sometimes the member had taken the FSL part 1 20 years previously.

The second meeting was held on February 19, 2016. There was discussion about the TPA of core and immersion teachers being done in English and/or by administrators with no or little understanding of French. When a member is evaluated on their teaching of French and the administrator evaluating is not able to understand French it can become concerning as to what the administrator is evaluating.

There was discussion about some school boards making changes to French Immersion programs and the concerns of job security for members as the immersion program goes to a 50% English 50% French. There was also a long discussion about a severe

shortage of DECEs who speak French in the Kindergarten French immersion programs.

The committee prepared a request for an FSL Caucus at the 2016 Annual Meeting. Committee members generated a number of possible topics for discussion at the caucus including: seeking support for any FSL resolutions and sharing and discussion of new French curriculum supports.

There were no resolutions submitted to the 2016 AGM.


The conference call that took place on Monday, May 30, 2016 was used to review the Annual Meeting resolutions dealing specifically with Human Rights.

#### Committee Activities 2015 - 2016

The committee met twice during the year on November 19, 2015 and February 8, 2016. The committee's activities in 2015-16 included the following:

- Executive Liaison Karen Brown Campbell brought greetings from the ETFO Executive
  and reviewed the Terms of Reference for Standing Committees. She discussed pertinent
  information about the 2015 Annual Meeting Resolution which was submitted by the
  Intermediate Division Standing Committee but did not make it to the floor. VicePresident Brown Campbell also provided the committee with valuable advice about
  moving forward with some of their goals.
- The committee took part in a collaborative activity based on the theme of "Mindfulness."
   The committee worked first individually prioritizing the needs of today's intermediate teachers and then debriefed the priorities as a whole group. The following priorities were highlighted:
  - 1. Unity amongst divisions in schools the intermediate division is often segregated from the rest of the school as Ministry policies and initiatives often focus on Kindergarten to Grade 6.
  - 2. Collaboration within the division no time to share plans, etc.
  - 3. The relationships between administration and teachers are often adversarial.
  - 4. There is a consistent feeling that the intermediate division is often left out while other

- divisions tend to be in the spotlight.
- 5. Lack of resources and professional learning opportunities for intermediate teachers.
- 6. The collapse of rotary in schools has been detrimental to members and to students.
- 7. Intermediate teachers are constantly being told by administration to ensure that their students are prepared for high school. Members feel that it is their role to teach the Grade 7 and 8 curriculum, not to be teaching preparation for Grade 9.
- 8. Student mental health issues are not being supported by school administration or board. This is a growing concern.
- 9. Intermediate teachers are expected to be grading on a percent scale yet all achievement charts are based on a 1 to 4 level scale.
- 10. Kindergarten teachers and Grade 8 teachers are the specialists at each end of the elementary program yet the balance of support is very uneven.
- C. Oliver outlined his recent report to the ETFO Executive. He provided the committee
  with details around what was shared.
- The committee decided to move forward with submitting another Annual Meeting Resolution requesting a conference for ETFO members teaching grades 6 to 8. They decided that their rationale would be the same as last year's. Last year's resolution did not make it to the floor. The resolution and rationale were as follows: That ETFO provide an Intermediate Conference in 2015-2016.

#### Rationale:

Recent member surveys and feedback forms indicate member need and interest for professional learning and support in the areas of inquiry-based learning, new curriculum, technology and transition to high school. A balanced approach to funding and support continues to be a need for intermediate teachers. Intermediate teachers make up a significant percentage of our membership and historically have not received the same focus in terms of funding, programs and resources as other divisions.

- The committee provided advice on a possible list of workshop topics that should be included in a conference. They were as follows: Math Proportional Reasoning and Teaching Strategies for Math, Integrating Language and the Arts, Student Mental Health (Supporting Minds 2013), Critical Thinking/Equity and Social Justice, Enhancing your Intermediate Program with Inquiry and Play-Based Learning, and Google Classroom.
- An Annual Meeting resolution <u>did not</u> have to be submitted as the Intermediate Conference 2016-2017 budget as submitted and proposed by J. Myers was approved. This issue has been addressed.

Committee members celebrated Deidre Buckley-McKie's article in the Summer 2015 edition of VOICE magazine in the hopes that it will generate further interest among ETFO members and draw attention to the wonderful international work of Project Overseas.

The International Committee implemented a rubric for scoring applications that was introduced last year. Committee members were sent the scoring rubrics ahead of time for reviewing applications. This new process worked well and ensured that committee members scored written applications holistically. A similar rubric was also used for telephone interviews. A "one-minute" question was again part of the telephone interviews, which was followed by six or more standard questions, developed in both English and French.

Thirty-four applications were received this year for Project Overseas 2016 - four more applications than were received for 2015. Of those 34 applications, 11 were returning Project Overseas alumni. Of the total number of applicants, 28 applicants identified themselves coming from a designated group, while 15 members were from a racialized group.

The second face-to-face meeting of the committee was devoted to telephone interviews of short-listed candidates. These applicants came from nine different locals with two interviews conducted in French.

The committee recommended 23 applicants to the Executive, all of whom were approved by the Executive. Of these, CTF selected 14 ETFO members to participate this summer, five ETFO members (whose names are bolded below) were selected as team leaders.

#### **Committee Activities 2015-2016**

There were two meetings that took place for 2015-2016. The meetings were held on Tuesday, December 1, 2015 and Friday, February 19, 2016. Devon K. Moore was appointed as the Chairperson of the committee.

Committee members discussed their recommendations from last year and were happy that the Kids' Union School is being piloted at this year's Annual Meeting.

#### Ontario Federation of Labour (OFL) Convention

Two members of the committee attended the Ontario Federation of Labour (OFL) Convention in November. They discussed how much they learned at the convention and how important it is for ETFO to be involved. The committee members shared the many differences between the Convention and our Annual Meeting, and felt there were definitely things that we could incorporate into our Annual Meeting (e.g. using the terms sisters and brothers, music in the morning and at lunch to welcome delegates, the visible and audible support for speakers). There was much discussion about the extra funding that ETFO provided this year that allowed more members to attend. Committee members thought it was an excellent idea and were thankful to the Executive for putting

it forward. They also brought up the possibility of incentive funding being made available for locals to bring members in their first five years as convention delegates.

#### **Labour Councils**

The committee had a lengthy discussion on Labour Councils and the varying degrees of functionality across the province.

Committee members discussed the idea of having an ETFO/CLC focus group that could give recommendations to the CLC regarding best practices in labour councils, and what steps could be taken for improvement.

The committee felt that data collection on labour councils would assist ETFO with getting a better sense of local involvement.

Committee members also discussed the idea of leadership training session for labour council delegates to more effectively participate in their labour councils. Committee members also talked about a one-day conference for labour council delegates from across the province that focused on the history of labour councils, how ETFO can be involved, etc.

By the end of the second meeting, the following recommendations were made:

- That ETFO conduct a focus group of local leaders, involved in Labour Councils, to discuss and make recommendations to the CLC regarding the functionality of Labour Councils.
- That ETFO offer a session at Leadership for labour council delegates to effectively participate in their Labour Councils.

#### **Recommendations to the 2016 Annual Meeting:**

- 1. That ETFO provide single room accommodation at the Annual Meeting at no cost for delegates who have sole parenting responsibility during the Annual Meeting.
- 2. That ETFO develop and pay the expenses for a two-day conference for ETFO Labour Council delegates from across the province.
- 3. That ETFO offer incentive funding, over and above previous funding, to locals who wish to send delegates to the 2017 Canadian Labour Congress in Toronto.

#### **Committee Activities 2015-2016**

The LGBTQ Committee met twice during the year on December 4, 2015 and February 19, 2016. The committee's activities in 2015-2016 included the following:

At its first meeting, the committee discussed that fact that many ETFO members are closeted and it is important to get Federation information to them on lesbian, gay, bisexual, transgender, queer or questioning (LGBTQ) issues. The group recommended that ETFO consider: putting the LGBTQ *Inclusive Schoolplace Starts Here* video on YouTube; increasing the number of members who subscribe to the ETFO e-Newsletter; and creating a Twitter account @ETFOpink and hashtag #ETFOpink to provide members with a social media channel to promote and share LGBTQ advocacy initiatives and issues.

Participants also discussed ways to encourage more members to support and attend Pride events such as appealing to both LGBTQ members and allies by emphasizing events other than parades and appealing to allies including students in GSAs and administrators.

At its second meeting, the committee invited a guest speaker from the Toronto Bisexual Network to provide insight on bisexual issues. About half of those who identify as queer identify as bisexual, de-bunking the myth that bisexuality doesn't really exist.

The committee identified ways for ETFO to support members facing homophobia, biphobia and transphobia. It recommended that ETFO:

- Professional Relations Services staff collect data on the types of human rights violations calls it handles while respecting the confidentiality and privacy of individual members;
- launch a closed Facebook group monitored by an ETFO staff member to provide a virtual forum to support and connect LGBTQ members, activists and allies;
- organize a conference for LGBTQ members and allies in 2016-2017 to provide a forum to explore, support and build connections and solidarity for challenging homophobia, biphobia and transphobia in school workplaces; and
- incorporate Two-Spirited realities into its First Nations, Métis and Inuit (FNMI) and LGBTQ professional development/learning.

# **Recommendations to the 2016 Annual Meeting:**

The committee submitted two recommendations to the Annual Meeting:

- 1. That ETFO lobby the Ministry of Education to implement training and accountability measures to ensure that principals comply with the Ontario Human Rights Code (OHRC), Equity and Inclusive Education Strategy and *Accepting Schools Act* when lesbian, gay, bisexual, transgender, queer or questioning (LGBTQ) members or students face discriminatory treatment.
- 2. That the Committee submit the 2015 Annual Meeting resolution from the Executive re: equity positions to the 2016 Annual Meeting.

The Chair thanked members Sheri Birch and Andres Musta for their service to the committee and the Federation.

#### **Committee Activities 2015-2016**

The committee met twice during the year on Monday, February 8, 2016 and Monday, April 11, 2016. At the time of writing this report the committee had also planned to meet by teleconference on June 22, 2016.

During the first meeting, the committee:

- Reviewed the Guidelines for ETFO Committee Members 2015-2016;
- Selected Johanna Gibson-Lawler, Greater Essex County Teacher Local, as the committee chair;
- Reviewed the committee's Terms of Reference and recommended to the Executive that one Term be changed to reflect the new vision of the 'school library learning commons':
- Reviewed ETFO Policy Statement 72 School Library Programs, and any other relevant Policy or Position Statements;

- Discussed the state of Teacher-Librarianship in Ontario public elementary schools by reviewing annual reports by People for Education, and by identifying issues that limit the effectiveness of school library learning commons programs;
- Recommended that the Executive consider conducting an online survey of local presidents to determine the existence and range of Teacher-Librarian roles and collective agreement language specific to Teacher-Librarians in each local;
- Wrote two Annual Meeting resolutions to lobby the government to staff school libraries proportionally based on student population, and to have dedicated library budgets for resources--again based on student population.
- Provided feedback to Executive Assistant Vivian McCaffrey on a background paper she wrote on the role of Teacher-Librarians and other specialist teachers.

# During the second meeting, the committee:

- Heard from Executive Liaison Nancy Lawler how Executive had dealt with recommendations from the first meeting;
- Reviewed the Annual Meeting resolutions submitted on behalf of the committee and discussed who would move and second the resolutions at the meeting;
- Discussed the issue of Teacher-Librarians being assigned prep coverage and subject-specific reporting duties, which limits their ability to deliver a proper library learning commons program;
- Discussed a Ministry announcement regarding funding for school libraries which might provide boards and principals with even more leeway to divert funds away from library programming.
- Accessed Secure Services to search for existing collective agreement language regarding Teacher-Librarians;
- In anticipation of the Executive approving the recommendation for an online survey of local presidents, began compiling survey questions.

# Recommendations to the 2016 Annual Meeting:

- 1. That ETFO, through OTF, lobby the provincial government to amend the funding formula to specify proportional staffing of Teacher-Librarians based on student population, with a minimum allocation of a 0.5 FTE Teacher-Librarian in each work site.
- 2. That ETFO, through OTF, lobby the provincial government to amend the funding formula to provide dedicated school library learning commons budgets; i.e., perpupil funding for library resources, both physical and virtual, allocated in collaboration with the Teacher-Librarian at each work site.

### **Committee Activities 2015-2016**

The Occasional Teacher Committee met on December 4, 2015, and on February 5, 2016. The Committee's activities in 2015-2016 included the following:

- The Committee discussed how misinformation or incomplete information on social media can impact occasional teachers. Members need to be cautious about the information they access online and remember that ETFO is a trusted source.
- The Committee members were provided information from the First Vice President regarding negotiated improvements through central table bargaining.
- The Committee asked for an update on the recommendations from the ETFO
  Task force dealing with allegations. Information was provided to the Committee
  regarding the allegations resource binder, leadership training on allegations and
  the Q and A document created to support a member who is facing an allegation.

- The Committee discussed whether a daily occasional teacher should deliver a
  lesson from the health curriculum since they may not know the class and may not
  have been provided with the necessary training on the curriculum. The
  committee concluded that it is incumbent upon boards to provide training to all
  teachers in regards to the new physical health education curriculum.
- The Committee expressed concern about the fair distribution of work for all daily
  occasional teacher members. Members who have apps are able to access many
  more jobs then members relying only on a board automated call out system. In
  order to ensure the fair distribution of daily work an examination of available
  options for automated systems needs to be conducted.
- The Committee discussed the need for funding for Occasional Teachers for professional learning in a separate budget line. There was discussion around what funding is currently available to Occasional Teachers through ETFO.
- The Committee discussed a potential ETFO Annual Meeting resolution which would address the issue of OT culpability when there is an allegation of physical contact with a student.

### Recommendations to the Executive

- That PRS Matters be developed regarding advice around the new Health and Physical Education curriculum with advice specific to daily occasional teachers.
- 2. That ETFO consider examining the options available with automated systems used to book occasional teachers for the purpose of assisting locals to negotiate fair distribution of work.
- 3. That ETFO consider the creation of new model collective agreement documents for locals now that bargaining is done at two tables (local/central).

# Recommendation to the 2016 Annual Meeting:

That ETFO give specific consideration to the vulnerability of Occasional Teachers where they have been requested to deliver lessons on potentially controversial curricula such as Health and Physical Education and other curricula of a sensitive nature. As part of this consideration ETFO shall create a PRS Matters bulletin recommending best practices for Occasional Teachers requested to deliver these curricula and for classroom teachers who may contemplate leaving lessons from these curricula for the Occasional Teacher to deliver.

## **Committee Activities for 2015-2016**

The Committee scheduled two meetings for December 11, 2015 and Friday June 10, 2016. At the time of this report, the June meeting had not yet taken place.

The Committee discussed best practices for building health and safety activism in their own locals with a focus on improved Joint Health and Safety Committee effectiveness. The Committee compared and contrasted multi-site and site-based Joint Health and Safety Committee (JHSC) structures and discussed some key factors of JHSC effectiveness. More than two-thirds of public school boards have a multi-workplace JHSC system with a central committee that includes representatives from both workers and management.

The Committee discussed the Ministry of Education's PPM 158 - School Board Policies on Concussions regarding student concussion, as well as concerns about concussion risks among ETFO members due to hazards such as falls, assault, and being struck by an object such as a ball. The Committee discussed the importance of effective reporting of suspected concussion for both adults and children, with medical attention as may be required.

The Committee discussed ongoing concerns about workplace violence and serious student incidents in schools, including local and provincial efforts to ensure such incidents are effectively reported, investigated and dealt with. Committee members shared strategies for improving effective response to workplace violence incident reports including the engagement of the superintendent, and the development of a safety plan that includes early interventions, access to immediate assistance, as well as crisis management.

The Committee met with the ETFO Standing Committee for Education Support Personnel, Professional Support Personnel, and Designated Early Childhood Educators to discuss common issues and concerns. The leading concern with the ESP, PSP, and DECE Committee was reporting issues regarding workplace violence. Examples of contributing factors included lack of information and instruction, and being discouraged by the principal from reporting incidents. Both committees recognized the potential for more joint training among union groups at the local level.

The Committee expressed concerns that some school boards permit the use of student volunteers in the office for answering the phones and/or speaking to visitors. The use of students as substitute workers is an unsafe practice that places the volunteering students and others at risk during emergency procedures for lockdown, bomb threat, fire, and medical.

The Committee recognized the serious health concerns related to asbestos in aging public buildings including schools and hospitals. The Committee discussed the mandatory asbestos registry that has been established in Saskatchewan and agreed that a public registry of buildings that contain asbestos should be established in Ontario. The Committee recognized that a mandatory and public registry of these buildings would help to ensure that asbestos-specific health hazards would be more quickly identified and more carefully controlled or removed.

# Recommendation to the 2016 Annual Meeting:

 That ETFO, through OTF and the OFL, lobby the Ontario government to establish a mandatory asbestos registry for Ontario public buildings including schools and hospitals.

### **Committee Activities 2015-2016**

The Committee participated in two face-to-face meetings. The first meeting was held on February 18, 2016. Carrie Nethery was acclaimed Chairperson. Executive Liaison Nancy Lawler brought greetings from the Executive to the Committee. The Terms of Reference and Guidelines of the Committee were reviewed. The Committee considered pension issues that might be faced by members who are at all stages of their careers, as well as members' overall financial literacy and financial health in retirement.

The outcome of pension related resolutions to the 2015 Annual Meeting were examined. The Committee discussed whether or not ETFO should produce a webcast for Ontario Municipal Employees Retirement System (OMERS) members. They were made aware of the number of times the ETFO webcast on the Ontario Teachers' Pension Plan (OTPP) had been viewed. They thought it would be helpful to get feedback from members who viewed the webcast as to whether the goals of this information being current and valuable were met. Committee members felt that further data was needed before recommending the creation of a webcast focussed on the OMERS. Committee members were provided with an update on communication tools

available to members of the OMERS and the OTPP. They reviewed the *myOMERS* and *iAccess Web* online tools. They also viewed electronic versions of the OMERS and the OTPP member magazines, and the various pension links on the ETFO web site. A great number of YouTube videos produced by the OTPP were also explored. The Committee confirmed that no resolutions would be submitted to the ETFO 2016 Annual Meeting.

The second meeting was held on April 8, 2016. An overview of the various presentations that took place at the OTF Pension Forum was discussed. The Committee Chairperson sought feedback on aspects of the Committee's work to present to the May Executive meeting she would attend. Time was spent reviewing the annual reports of both the OTPP and the OMERS. Committee members suggested that ETFO members be made aware of the updated financial results of both the OTPP and the OMERS, as well as the webcasts available on each pension plan's website through presnet or the e-newsletter. They also encouraged ETFO locals to consider sending members to attend either the Annual Meeting of the OTPP or the Spring Information Meeting hosted by the OMERS.

Rian Fortier completed the second year of his second term as a member of the Pension Committee. Members of the Committee thanked him for his commitment and contributions, and wished him well on his future endeavours.

#### **Committee Activities 2015-2016**

The Teacher Education/Faculty Liaison Committee (TEFLC) met three times this year: Friday, October 16, 2015; Friday, February 26, 2016; and Friday, April 29, 2016.

Earlier at the October 2015 meeting, an orientation meeting was held for members new to the committee. S. Swackhammer, Executive Liaison and First-Vice President, welcomed the new members and extended thanks to returning members. She provided an overview of the role and responsibility that the Executive Liaison plays as the Executive representative for the TEFLC and the role that the TEFLC plays. She expressed regret that the Nipissing Brantford campus is closing. Joanne Threndyle was elected chair. Staff highlighted the importance of keeping good communication between the TEFLC member, executive and support staff responsible for TEFLC to ensure that all information is communicated. New wording for the Faculty of Education award was discussed as well as issues at the TED table. The committee had a look at the Teacher

Education Application Service (TEAS) statistics for the first year of the 2 year program. Both oral and written committee reports were presented by the TEFLC members.

At the February 26, 2015 meeting, the committee began the process of revising the ETFO Standing Committee pages on the website, to better outline the roles, responsibilities and number of meetings locally and provincially. We discussed the importance of tracking a multi-year plan for workshops so teacher candidates do not receive the same workshop more than once. The committee discussed issues at the TED table including the high turnover in Deans of Education, shortage of qualified French teachers and fewer course offerings at the faculties. We continued to discuss the Faculty of Education Award considering the amount of the award, timing, application procedure and selection of recipient.

At the April 29, 2016 meeting, the committee finalized a recommendation to the Executive around the Faculty of Education Award. We revisited and identified challenges in selecting candidates. The committee would like to see the Award increased to \$1000, have the application initiated by the student, and the selection should be made to the ETFO Awards committee. The committee also finalized the wording about the ETFO TELC to be used on the website. We discussed the TED table recommendations that will be going forward regarding Francophone Education, Teachable Subjects and Aboriginal Education. The TEAS statistics reflect a consistent number of applicants to faculties from last year. The committee looked at the OCT Transition to Teaching 2015 report and focussed on the number of members/grads who are not renewing their licences. The final discussion the committee had was the need for teacher candidates to do OT practicum work during their placements since almost all of them will begin their career in the role. Thanks were extended to the 2 members who will not be returning to the committee next year.
